## NextGen is Coming in 2020!

The Bankruptcy Court for the Northern District of New York will be upgrading its CM/ECF software to the Next Generation of CM/ECF ("NextGen"). NextGen implementation activities will begin in early 2020. The implementation process generally takes about 8 months to complete. Thus, we anticipate going live with NextGen in the early fall of 2020. NextGen maintains existing CM/ECF functionality while adding central sign-on for public and judiciary users. This new feature will allow users to maintain one account across all NextGen courts (bankruptcy, district and appellate). This means that attorneys will be able to use one login and password to access PACER and all NextGen courts where they have permission to file. This feature will also provide a centralized functionality for attorney registration and admissions. NextGen CM/ECF should provide greater consistency in user experience, especially for external users.

## Debtor's Attorney's Fees in Chapter 13 Cases filed in the Albany and Utica Divisions, Effective June 15, 2019

By Administrative Order 19-01 signed by Judge Robert E. Littlefield, Jr. and Judge Diane Davis, the options available to a debtor's attorney and the procedures that will generally be followed by the Court in the Albany and Utica divisions with respect to attorney's fees and costs have been revised. Administrative Order 19-01, along with a revised *Rights and Responsibilities of Chapter 13 Debtors and Their Attorneys* form (the "Revised R & R"), are effective June 15, 2019. ## Loss Mitigation Annual Statistics

The Loss Mitigation Program was commenced in the Northern District of New York on July 13, 2013. The Loss Mitigation Program Procedures and forms are available under the Loss Mitigation tab on the home page of the Court's website.

During the period of September 1, 2018 through August 31, 2019, 208 Loss Mitigation Requests were filed. During the same time frame, approximately 206 Orders Terminating Loss Mitigation and Final Reports were filed. Approximately 110 requests resulted in a loan modification and approximately 46 requests resulted in the parties being unable to reach an agreement. Other dispositions reported, although less frequently, included short sales, surrender of real property, and termination for debtor's failure to file required documentation.

## Amendments to Local Bankruptcy Rules

On August 16, 2019, redline versions of the proposed amendments to Local Bankruptcy Rules 1002-1, 2019-1, 4001-1, 5005-1, 7003-1, 7055-1, 9013-1, and 9037-1 were posted for public comment to the court's website under News & Announcements and disseminated via GovDelivery. The amendments will go into effect December 1, 2019. Some of the amendments are the result of changes to the Federal Rules of Bankruptcy Procedure ("FRBP") that also take effect December 1, 2019. Others were based upon comments received by the Local Rules Standing Committee from the bench and bar.

Local Bankruptcy Rule 1002-1 (Commencement of the Case) was amended largely to align with the FRBP 1002. The portions of the Rule and the Comment referencing filing fees were removed as they are included in Local Bankruptcy Rule 1006-1 (Filing Fee). Other changes were largely stylistic.

Local Bankruptcy Rule 2091-1 was amended to clarify that you may be relieved as attorney of record for a debtor only upon an order obtained after notice and a hearing. Relief may not be obtained ex parte. The underlying motion must be supported by an affidavit stating satisfactory reasons for the withdrawal and a statement of the status of the case.

The information that must be included in a motion for relief from the automatic stay is set forth in Local Bankruptcy Rule 4001-1(a) (Relief From the Automatic Stay). In addition, under paragraph (b), in the case of an individual debtor, if the motion involves real property and is based upon payment default, the movant must file with the motion a Certification of Payment

History of the Note and Mortgage ("Certification"). The only exception is if the debtor intends to surrender the property the Certification is not needed. If the required information and/or Certification is not included with the motion, the motion may be denied. Local Bankruptcy Rules 4001-1 is amended to remove the requirement that the request that the motion be denied must be made by a party in interest. This change is meant to clarify that the motion may be denied sua sponte by the court.

A new paragraph (b), "Place of Filing," was added to Local Bankruptcy Rule 5005-1 (Electronic Filing and Service) to align with FRBP 5005.

Amendments were made to Local Bankruptcy Rule 7003-1 to explain the conflict between the Rule and the instructions for the adversary proceeding cover sheet. The instructions indicate that the cover sheet is not needed if an adversary complaint is filed electronically through the Court's CM/ECF system. The changes explain why the Clerk's Office needs the information captured on the adversary proceeding cover sheet. A link to a cover sheet in fillable pdf format was added to the Comment. The fillable form is also available on the Court's website.

FRBP 7055 provides, "When a party against whom a judgment for affirmative relief is sought has failed to plead or otherwise defend, and that default is shown by affidavit or otherwise, the clerk must enter the party's default." The word "affidavit" in Local Bankruptcy Rule 7055-1 (Default Judgment) was changed to "sworn statement" to make clear that a sworn statement qualifies under the "or otherwise" language of FRBP 7055.

Paragraph (b) of Local Bankruptcy Rule 9013-1 (Motion Practice) was retitled "Notice and Service Generally." Additionally, the phrase "pleading or other document" was replaced with "notice, motion or other paper" to conform with the amendments to FRBP 9036, which address notice and service by electronic means. In addition, a new paragraph (o) setting forth requirements for local counsel was added to the Rule. Local counsel representing a party in place of counsel of record must be admitted to practice before the District Court of the Northern District of New York and should be fully versed in the matter before the Bankruptcy Court.

FRBP 9037 was amended to require that a motion to redact be served upon the debtor, debtor's attorney, trustee, if any, United States trustee, filer of the unredacted document, and any individual whose personal identifying information is to be redacted. Local Bankruptcy Rule 9037-1 is amended to incorporate this notice requirement.

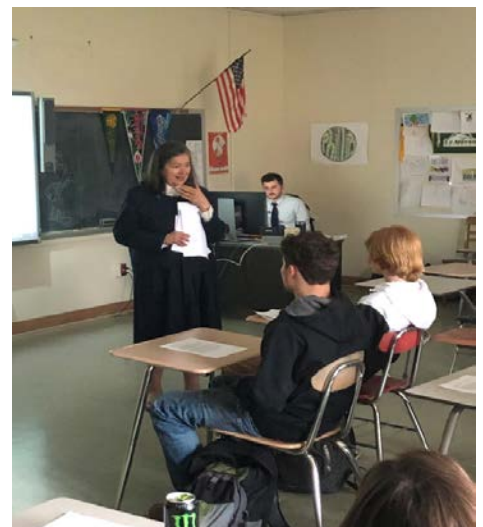

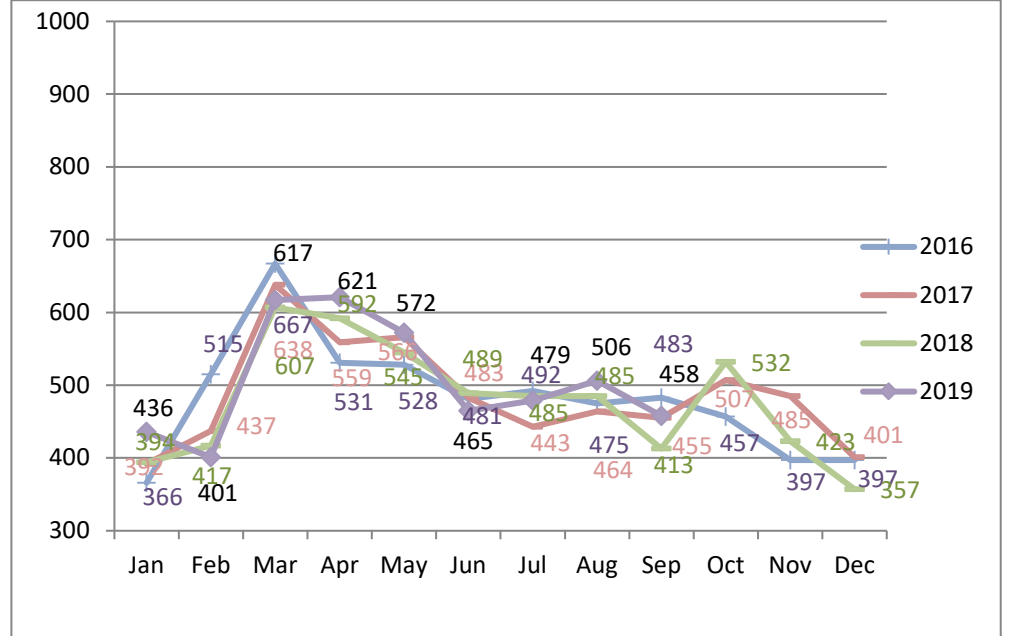

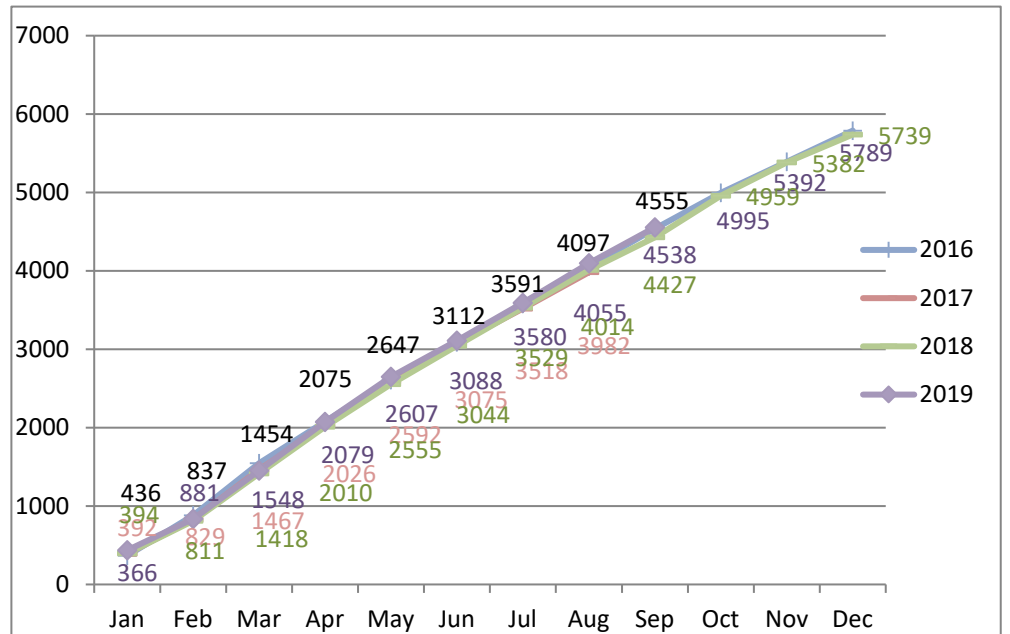

**ON THE RECORD WITH THE AO**

**NEWS FROM THE ADVISORY COMMITTEE ON BANKRUPTCY RULES**

My summer column typically provides a brief preview of bankruptcy rule and form changes on track to go into effect this year, and lists any proposed rule and form changes that have been published for comment.

***Bankruptcy Rules and Forms effective December 1, 2019***

The following rules and forms are on track to go into effect on December 1, 2019: Bankruptcy Rules 4001, 6007, 9036, and 9037, and Official Form 122A-1. In addition, one new director's form will be issued to facilitate the collection unclaimed funds.

*A. Rule 4001*

Rule 4001(c) (Obtaining Credit) sets forth requirements for obtaining court approval of post-petition credit in a bankruptcy case, including the filing of a motion containing detailed disclosures and information. The proposed amendment makes Rule 4001(c) inapplicable to chapter 13 cases. The Advisory Committee concluded that most of the required disclosures were developed for issues relevant in chapter 11 cases and that these disclosures are unnecessary and unduly burdensome in chapter 13 cases.

*B. Rule 6007*

The amendments to Rule 6007(b) (Abandonment or Disposition of Property) are designed to specify the parties to be served with a motion to compel the trustee to abandon property under § 554(b) of the Bankruptcy Code, and to make the rule consistent with Rule 6007(a) (dealing with abandonment by the trustee or debtor in possession).

*C. Rule 9036*

The amendments to Rule 9036 (Notice by Electronic Transmission) allows clerks and parties to provide notices or serve documents (other than those governed by Rule 7004) by means of the court's electronic-filing system on registered users of that system. They also allow service or noticing on any person by any electronic means consented to in writing by that person. The service or notice is complete upon filing or sending, but it is not effective if the filer or sender learns that it was not received.

*D. Rule 9037*

The proposed amendment to Rule 9037 (Privacy Protection For Filings Made with the Court) adds a new subdivision (h) to address the procedure for redacting personal identifiers in previously filed documents that are not in compliance with Rule 9037(a).

*E. Official Form 122A-1*

The instruction on line 14a of Official Form 122A-1 (*Chapter 7 Statement of Your Current Monthly Income*) is amended to remind a debtor for whom there is no presumption of abuse that Official Form 122A-2 (*Chapter 7 Means Test Calculation*) should not be filled out or filed.

*F. New Director's Form 1340*

At its April 2019 meeting, the Advisory Committee reviewed a proposed draft director's bankruptcy form for an application for withdrawal of unclaimed funds in closed bankruptcy cases, along with proposed instructions, and proposed orders (Form 1340, Application for Payment of Unclaimed Funds). The initial draft was the product of the Committee on the Administration of Bankruptcy's Unclaimed Funds Task Force. The Advisory Committee supported the idea of a nationally available form to aid in processing unclaimed funds, made minor modifications, and recommend that the Director adopt the form.

***Rules and Forms Published for Comment***

Bankruptcy rule and form amendments are generally published for public comment for approximately six months from mid-August to mid-February along with any proposed amendments to other rules of procedure or rules of evidence in the "Preliminary Draft of Proposed Amendments." Four bankruptcy rule amendments are out for public comment this cycle: Rules 2005, 3007, 7007.1, and 9036.
