Utica Division Case Assignments

Effective October 1, 2025, all new cases and related adversary proceedings filed in the Utica Division will be assigned to either Chief Judge Wendy Kinsella or Judge Patrick G. Radel based upon the county in which the domicile, residence, principal place of business or principal asset(s) of the debtor is in.

Cases and related adversary proceedings filed from Broome, Chenango, Delaware, Franklin, Fulton, Lewis, Madison, Montgomery, Otsego and St. Lawrence Counties will be assigned to Chief Judge Kinsella.

Cases and related adversary proceedings filed from Hamilton, Herkimer, and Oneida Counties will be assigned to Judge Radel.

In addition, beginning September 29, 2025, most pending cases and related adversary proceedings from Broome, Chenango, Delaware, Franklin, Fulton, Lewis, Madison, Montgomery, Otsego, and St. Lawrence Counties in the Utica Division will be reassigned to Chief Judge Kinsella. Details about cases and related adversary proceedings from these counties that will remain with Judge Radel will be forthcoming as they are determined. Following the reassignments to Chief Judge Kinsella, the judge's initials at the end of the bankruptcy case and adversary proceeding numbers will change to "WAK," but the case and adversary proceeding number will remain unchanged.

Parties may appear in-person at the Alexander Pirnie U.S. Courthouse and Federal Building, 10 Broad Street, Utica, New York, or by video via Microsoft Teams for motion and confirmation hearings.

It is anticipated that Judges Kinsella and Radel will each hold one calendar a month in Utica on a Tuesday.
