

Interactive Public Calendar

The Interactive Public Calendar (IPC) powered by ChapMobile displays 30 days of scheduled court hearings and 341 meetings. The IPC allows a user to:

- View current and upcoming hearings organized by judge and 341 meetings organized by trustee;
- Search by judge, trustee, attorney name, debtor, or case number; and
- Sort, view, download, and print custom calendars.

The IPC updates automatically via data from CM/ECF approximately every 10 minutes. Please see the IPC User Guide below.

Interactive Public Calendar User Guide

The interactive public calendar (powered by ChapMobile) displays 30 days of scheduled court hearings and 341 meetings. The calendar allows users to:

- View court hearing calendars for all Judges or filter by Judge;
- View 341 calendars for all Trustees or filter by Trustee;
- Search hearing calendars and 341 calendars by Attorney, Debtor or Case Number;
- Download calendars for viewing or printing.

Click the settings icon 🔯 to set data filters and modify the view of the Interactive Public Calendar.

Calendars may be downloaded for viewing or printing when the 🛃 icon is visible.

The interactive public calendar will not display the Hearing Calendar and the 341 Calendar simultaneously. The Hearing Calendar is the home (default) screen.

To view the 341 Calendar, click the 341 Calendar link in the upper right corner.



Click the Hearing Calendar button to return to the Hearing Calendar.
