



**CLERK OF COURT'S NOTICE TO THE BAR AND THE PUBLIC RE:**

**REASSIGNMENT OF CHIEF JUDGE DAVIS'  
CASELOAD EFFECTIVE MARCH 5, 2023**

Effective March 5, 2023, and until the appointment of Chief Judge Davis' replacement, the transition plan for cases and related adversary proceedings pending in the Utica Division will be to reassign them to other judges as follows:

**Chapters 7, 12, and 13 Bankruptcy Cases and Related Adversary Proceedings**

Judge Wendy Kinsella will handle the Utica Division Southern Tier cases (Broome, Chenango, Delaware, and Otsego Counties), and Judge Robert E. Littlefield, Jr. will handle the Utica Division Northern Tier cases (Franklin, Fulton, Hamilton, Herkimer, Lewis, Madison, Montgomery, Oneida, and St. Lawrence Counties).

Notwithstanding the above reassignments, Judge Kinsella's conflict cases set forth below will be assigned to Judge Littlefield.
